

# What is Pupillage?

Pupillage is the final, practical stage of training to become a barrister. It is known formally as the Professional Stage. It is either completed in a set of chambers or with another Authorised Training Organisation (ATO) such as the Crown Prosecution Service (CPS) or in a solicitors firm or other organisation.

Pupillages usually start in September or October, one year after being accepted by the chambers/ATO (so, for example, successful April 2015 applicants will usually commence pupillage in autumn 2016). However, they may start at other times, depending on the set of chambers or ATO.

Pupillage lasts for 12 months and is formally divided into two parts, although precise arrangements may vary depending on a chamber's setup: the 'first six', which is the non-practising six months, and the 'second six', during which pupils may begin to carry out work of their own.

During the first six, pupils will be assigned a pupil supervisor – a barrister in the same set of chambers or organisation – who the pupil will shadow, and for whom the pupil will undertake supervised work, such as legal research and drafting court documents. The pupil will also accompany the pupil supervisor to court and conferences with clients.

During the second six, pupils will be eligible to undertake cases of their own, albeit under supervision, and will begin to build up their own contacts and a client base. Once the first and second six (i.e. the first 12 months) are satisfactorily completed, the pupil will be a fully qualified barrister.

If a pupil is not offered tenancy at the end of their pupillage year, they may stay on for six months at the same chambers or a different set of chambers, known as a 'third six'. In that situation, the pupil would have a full practising certificate and take on their own cases, but would not be a permanent member of chambers.

Chambers are required to fund pupillage with a minimum award of £12,000 (split into £6,000 for each six months with the award for the second six being guaranteed minimum earnings). The award may well be more (and often is), depending on the chambers or ATO – please see individual vacancies. The pupil may earn more than the minimum guaranteed earnings in the second six. Some chambers may offer a draw-down of the pupillage award to help pay for the BPTC.

Decisions about tenancy are usually made about ten months into pupillage. Appraisal might be based simply on a pupil supervisor's assessment of a pupil's abilities, or the pupil might have to take part in a formal exercise. Most sets of chambers take on every pupil with a view to making them a tenant if they perform well, but not all do.

# Top tips!



When you are discussing pupillage with a chambers/ATO good questions to ask are:

- » What kind of experience do you like your pupils to have?
- » How much time will I spend in court?
- » How many different barristers will I be with?
- » What percentage of pupils are taken on as tenants?
- » How much can I expect to earn in my Second Six?
- » Can I draw down from my pupillage award to help pay for my BPTC?

# The Pupillage Gateway

The Pupillage Gateway is the online application system for pupillage operated by the Bar Council. All vacancies will be advertised on the Pupillage Gateway, and approximately 100 chambers will require you to apply through the system. The Gateway includes a wide range of search criteria, the ability to store data from previous applications, and a good time period in which to prepare your applications. The Gateway will allow you to tailor your applications to individual chambers.





# APPLY

All pupillage vacancies are required to be advertised on the Pupillage Gateway. You can apply to up to 12 sets of chambers or ATOs via the Gateway. However, while all vacancies are viewable on the site, not every chambers or ATO will recruit through the Gateway, so please take note of the information being requested with each advert and the different deadlines.

Following calls from students and chambers, the Bar Council has moved the Pupillage Gateway timetable to January from 2017. The decision will mean that Pupillage applicants know the outcome of their applications before they commit to the expensive Bar Professional Training Course (BPTC) and Pupillage interviews will no longer risk clashes with exams.

# The Pupillage Gateway timetable

October 2016

Chambers and other ATOs are able to start inputting their adverts to go live to applicants in November.

28 November 2016

Applicants may access the Pupillage Gateway to browse Gateway pupillage vacancies (for chambers that do not recruit through the Gateway, adverts are live all year around). A practice online application form will be available in addition to a sample application form in pdf format for applicants to begin preparation.

09 January 2017

The submissions window for applications opens. Applicants can start, develop, submit and edit live applications.

06 February **2017** 

The submissions window for applications closes; no further applications or amendments to applications will be allowed.

February - April 2017

First and second round interview offers are sent out, and interviews are conducted by chambers.

03 May 2017 Offers of pupillage are made through the system. For applications made by candidates through the Pupillage Gateway, offers of pupillage must not be made or accepted before 9:00am on Wednesday 3 May 2017.

### Why do I have to join an Inn of Court?

Every prospective barrister in England and Wales must join one of the four Inns of Court. The Inns of Court are the only organisations authorised to Call people to the Bar of England and Wales.



### What are the chances of my application for membership of the Inn being rejected?

The system of joining an Inn generally operates as "you choose your Inn, your Inn doesn't choose you". The main exception to this is if you have a criminal record. In that case, you will have to provide details of your conviction along with your application for membership. You should contact the Memberships Officer of the Inn you wish to join for further details.



### Is there a deadline for applying to the Inn?

You must submit your application to join the Inns of Court by 31 May of the year you commence the BPTC.



# When is the best time to join an Inn of Court?

For those studying a Law degree, it is recommended that you join an Inn of Court from the second year of university. If you are studying/studied a subject other than Law at undergraduate level, wait until you have confirmation of your acceptance onto the GDL



You should also bear in mind that if you join an Inn of Court before applying for a BPTC or GDL scholarship, you must apply to your Inn for a scholarship rather than look at the scholarship programmes at each of the Inns of Court and choose which you wish to apply to then.



# **Scholarships**

What do the Inns look for in BPTC scholarship applicants?

Strong academic record. Applicants should aim for at least a 2:1 in their undergraduate degree. A-level results will also be taken into account.

Commitment to the law and more specifically a career at the Bar, and an understanding of what a career at the Bar entails. This can be evidenced through relevant work experience and most importantly through mini-pupillages. The majority of BPTC scholarship applicants have completed between 3 and 5 mini-pupillages. Applicants for GDL scholarships will also have completed a number of mini-pupillages.

# Scholarships continued...

**Experience of developing transferable skills** through activities such as debating, mooting, drama and public-speaking, as well as carrying out probono work.

**Interests other than law.** Many of the strongest scholarship candidates will have an interest in or participate in activities totally unrelated to the Law, such as team sports, travelling, learning languages, etc.

# How many applications do the Inns get for BPTC scholarships/how many scholarships do the Inns award each year?

The number of applications received varies year-onyear. The number of awards that may be made each year is not fixed.

In an average year, the Inns collectively give away over £5 million worth of scholarships. These funds are distributed between the BPTC, GDL/CPE,

Internships, Pupillage and other awards.

# Can you apply to more than one Inn for a scholarship for the GDL/BPTC? What happens if you do?

You must only apply to one Inn of Court for a scholarship. If you complete applications to more than one Inn, this will be detected and you will be asked to choose which application you wish to continue with.

# When is the deadline for applications for GDL/BPTC scholarships?

The deadline for BPTC scholarships is the **first Friday in November** of the year before you commence the BPTC. This is an absolute deadline. All four Inns of Court operate the same deadline. The deadline for applications for GDL scholarships is the **first Friday in May** of the year you start your GDL. All four Inns of Court operate the same deadline.

### What should I be doing now to put myself in a strong position to obtain pupillage?

Mini-pupillages, legal work experience, extra-curricular activities, attending events, marshalling a judge, mooting, debating and scholarships.

### What are the differences between the four Inns of Court?

When deciding between the four Inns of Court, prospective students often compare scholarships, ethos, education and training opportunities and membership. You should consider exploring the websites of each Inn to see what services are offered to students and members. We recommend you take a tour of each of the Inns to consider which has the atmosphere that appeals most to you.



### What are qualifying sessions?

All BPTC students are required to complete 12 Qualifying Sessions, in order to be Called to the Bar.

Qualifying Sessions must include an educational component and a collegiate component. Qualifying Sessions vary from Inn to Inn so you should research what is on offer at each Inn before choosing which Inn you wish to join.

Out of London BPTC institutions also run Qualifying Sessions and students studying outside of London can complete a maximum of 4 of these 'local' events at their institution.



### How much do pupils earn?

This very much depends on which area of the law you wish to practise. All pupillages must now be funded to a minimum level of £6,000 in the first six months, and £6,000 plus reasonable travel expenses during the second six months. The award for your first six months of pupillage is tax-free.

Pupillage awards vary widely between different chambers, and between different practice areas. Many sets of chambers offer just the minimum level. Some sets, typically doing commercial law, offer up to £40,000 or more.

### If I become a barrister, do I have to work in chambers?

No. Working in chambers is known as working at the Self-Employed Bar. Approximately 80% of barristers work in this way. However, the remaining 20% of the profession works at the Employed Bar. This means barristers work in solicitors' firms as in-house counsel, for the Crown Prosecution Service (CPS), Government Legal Service (GLS), local government, charities in industry or for organisations such as universities.

There are many benefits in being at the Employed Bar, including a regular salary, sick and maternity pay, and annual leave

It is possible to do your pupillage at the Employed Bar (for example, you can currently do pupillage at the Crown Prosecution Service, GlaxoSmithKline, Birmingham City Council, the Nursing and Mid-wifery Council or the Ministry of Justice).

### What role does my Inn have during pupillage?

While completing your BPTC, you will have the greatest contact with your Inn, whether it be for financial support or organising Qualifying Sessions which you must have attended. During pupillage, the Inn will provide you with essential vocational training. There will be a one-off membership fee of around £100.

### How can I attract the right chambers?

Firstly, if you are not sure exactly what area to practice in, consider applying to a mixed set. Secondly, sell yourself. Use your experience, whether it be mini-pupillages or business related activity to explain where your motivation to have a career at the Bar has come from; what went well and what demonstrates that your abilities and strengths will make you shine at the Bar; who and what motivated you; your natural strengths and how you use these in different situations. Research the chambers you're applying to and demonstrate how your interests and experience match what they're looking for - don't hold back but make sure what you're including would be attractive to that specific chambers.
